 - A. **Motion** to appoint Zachary Arnold, as a Seasonal DPW Worker at a rate of 17.87, effective April 14, 2025
 - B. **Motion** to authorize the Mayor to attend NYCOM's annual meeting in Bolton Landing, NY from May 28-30, 2025, with a cost not to exceed \$1,000.00 (Budgeted item)
